Notice is hereby given that the UWA Christian Union will hold its Annual General Meeting at 4pm on Thursday 28 September 2023 in Arts Lecture Room 10.

The AGM is a great opportunity to thank God for the year that has just been and to look forward to 2024. We will hear reports from the CU President, Treasurer, and Staff Team Leader and elect a new committee to lead us into 2024.

To nominate for the 2024 committee or vote in the elections you need to be a financial member (it costs \$5), so if you want to be involved in the AGM, fill in the attached forms and give them to the 2023 secretary Edward Charles.

Thinking of running for committee? That's great! Thanks for considering serving CU. Here's a bit more information about what the Committee does...

The Committee's role is to lead the Christian Union in proclaiming Jesus Christ at university to present everyone mature in Him. They are responsible for modelling Christ-like character and convictions to the CU, spurring on CUers in our mission, and planning and coordinating the running of CU throughout the year.

Committee members are expected to be actively engaged in building up the body of Christ on campus through sharing the gospel with non-Christians and encouraging Christians. They are also expected to attend Public Meeting, a small group, Equip and MYC, as well as other occasional events that CU runs. Committee members often play an important role as leaders of small groups and/ or workgroups too.

President The president's primary role is to lead the Christian Union by leading the Committee. He/she is responsible for helping the committee set our direction, tone, and activities for the year.

Vice President The VP has no set responsibilities except to lead CU when the CU president cannot. That means they have lots of flexibility and freedom to work out where there's a need and to help fill that gap.

Secretary The secretary keeps a record of the decisions the Committee makes and ensures that the rest of the committee knows what they were! They also deal with various paperwork, including correspondence with CUers and other organisations. On a weekly basis, the position tends to involve small but semi-regular odd jobs.

Treasurer The treasurer is responsible for managing the financial resources of CU so that we can best achieve our mission of proclaiming Jesus Christ at university to present everyone mature in Him. Our mission is not to make a profit, but our ability to carry out our mission is hampered when we have no money!

General Committee Members General Members have no specific responsibilities defined by the CU constitution, but they should be a key part of the decision making and planning of Committee. They have the freedom to take on a wide variety of tasks to help the Committee achieve its aims.

Who should I nominate for committee?

- Someone who has been a Christian for a while and clearly loves Jesus.

- Someone who can in good conscience sign our doctrinal basis.
- Someone who is self-controlled, not greedy, angry, a drunkard, or sexually immoral.
- Someone who is held in good regard by both Christians and non-Christians.
- Someone who is willing to lay down their life to serve others.
- Someone who has shown some capacity for leadership.
- Someone who wants to do it!
